### **PROGRAM OVERVIEW**

AT&T Legal Scholars is a collaboration between AT&T's Legal Department, Lawrence & Bundy LLC, and Kilpatrick Townsend & Stockton LLP as part of these entities' efforts to promote diversity and inclusion within the legal profession. AT&T Legal Scholars is a two and a half-day intensive workshop designed to provide participants with insight into the legal profession and the tools necessary to succeed in law school. Among other things, Selected Scholars will experience simulated law school classes and will receive feedback on graded homework assignments; will receive instruction on legal writing and resume writing; will be guided on case-briefing, outlining and time management; and will hear from law school deans and current law students on how to successfully transition from the last year of college to the first year of law school. Scholars will also have the opportunity to network with and develop personally and professionally from in-house counsel in a Fortune 10 corporation and other heavy hitters in the Atlanta legal community. The 2021 dates for the AT&T Legal Scholars program are July 22 – 23 and will take place virtually.

Space is limited. Thus, interested students are encouraged to apply early.
