Emory University School of Law's Juris Master program is designed to help employees broaden their knowledge of the law as it relates to their industry, enhancing their skills so they become even more valuable to their employers.

### Benefits of the program to your organization

#### Assess risk and make more informed decisions

Students learn to navigate a wide range of legal matters, from detecting ambiguities in contracts to understanding the potential legal issues associated with privacy and information security systems.

#### Navigate complex regulatory environments

Professionals must understand the evolving legal and regulatory landscape as it relates to private and public organizations, be able to manage complex deals and transactions, and comply with regulations. The Juris Master program equips employees with the skills necessary to navigate these challenges.

The Juris Master degree provides a comprehensive working knowledge of the employee's chosen field. Graduates can interact with legal counsel and outside parties more efficiently and identify and manage important legal issues.

### Four concentrations designed for working professionals

- > **Business Law and Regulation** covers corporate governance and compliance, civil liability for corporations, regulation, legal frameworks for deal making, and transactional due diligence, among other topics.
- > **Data, Privacy, and Technology Law** covers topics such as privacy, ethics, and the use of artificial intelligence in the workplace; trademark, patent, and copyright law; and licensing and trade secrets.
- > **Employment Law / Human Resources** explores employment at will, employees versus independent contractors, employee privacy in the workplace, workers' compensation, disability, and discrimination, among other topics.
- > **Health Care Law, Policy, and Regulation** explores topics related to health care regulation, mental health policy, law and public health, disability, the business of health care, and more.

## What is the time commitment for my employee?

The JM is a 30-credit-hour master's degree, available online, allowing students to get a degree while they work.

The online format is composed of 10 sequential asynchronous courses, with two synchronous online experiences, and can be completed in as little as 20 months.

For students enrolled in the JM program, tuition will be charged on a per-credit-hour basis. The tuition rate for 2022-2023 is approximately \$2,083 per credit hour.
